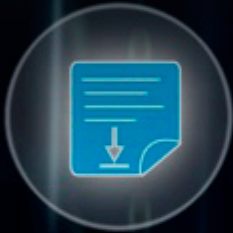
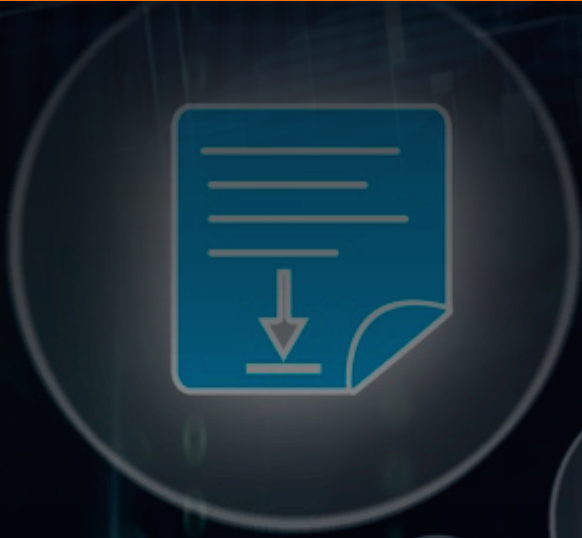

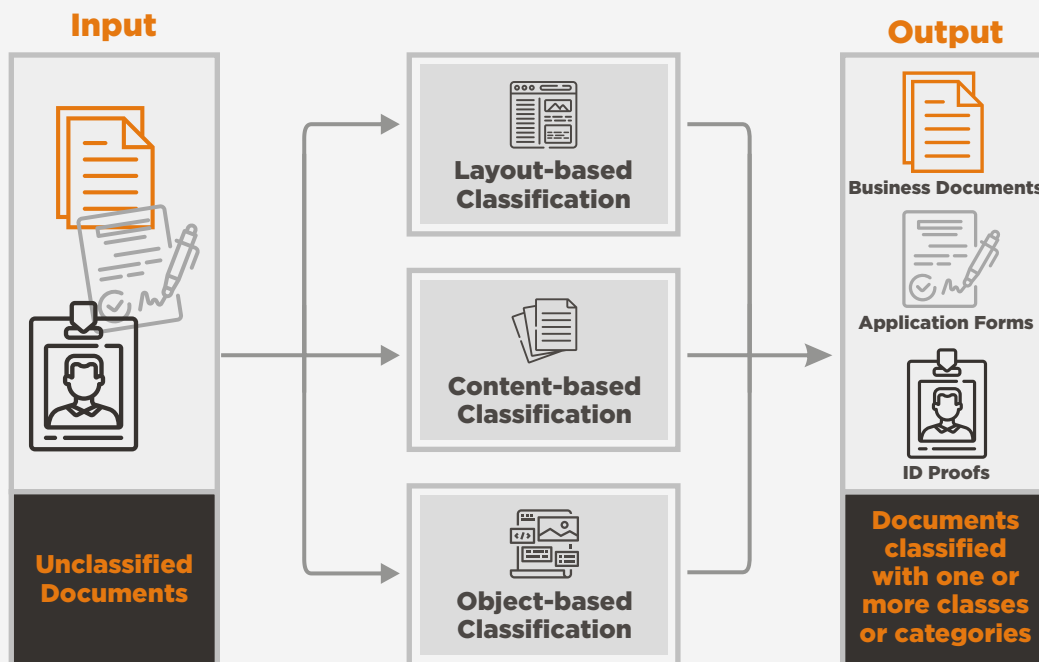

- **Support for Large Volumes of Documents**

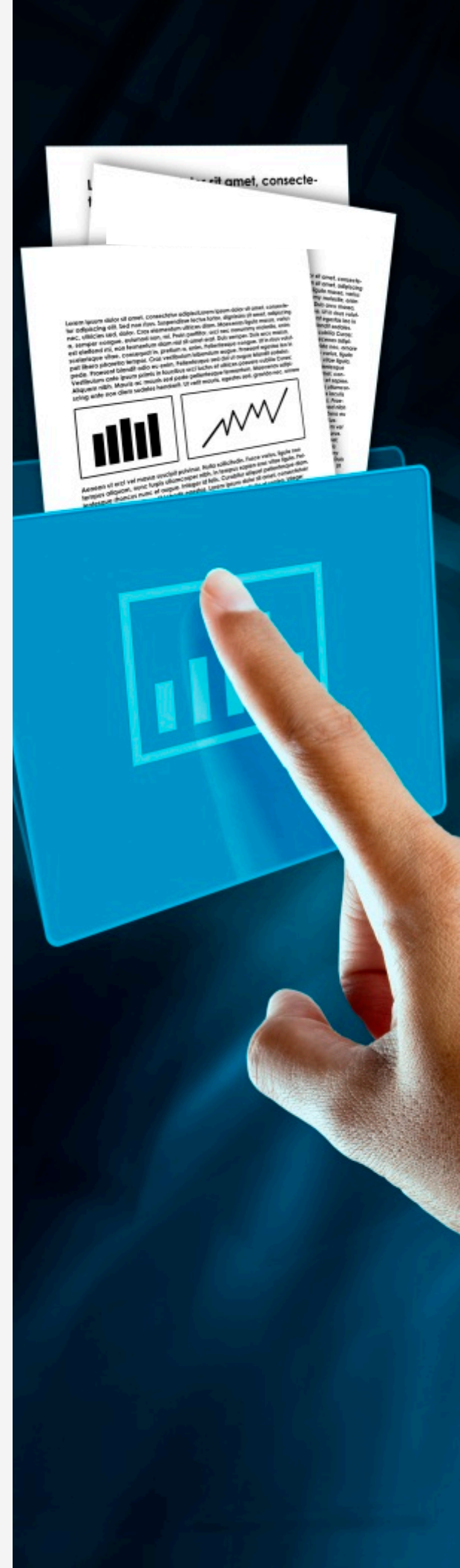
Users can import documents in bulk and the solution automatically assigns a document class to each document
