Challenges Posed by Traditional Bid Management Process

Dependency on physical documents

Manual processes

Manual vendor registration process is time-consuming and error-prone

Low visibility into the process

Bid managers do not get real-time visibility into bid management processes, including submission and evaluation. This further leads to low transparency and dissatisfaction among vendors

Low Information Security

Due to high dependency on physical document processing, there is a high risk of documents getting misplaced

Absence of tracking mechanism

There is no tracking mechanism for vendors to track the status of tenders


