Predictive Marine Cargo Loss Reserving Model

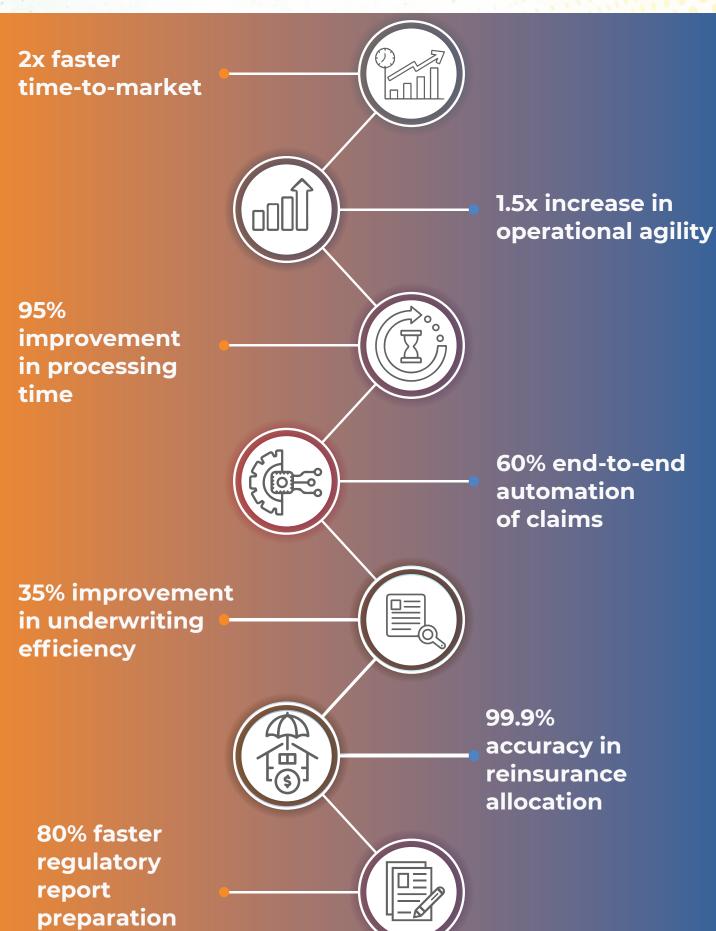
