## Understanding with Use Cases of EHR Connector for Health Plans

#### **Use Case 1: Faster Pre-authorization of Appeals for Payers**



**Scenario**: A denied MRI authorization requires staff to manually chase the provider for records via fax/emails, delaying resolution



**Solution**: EHR Connector auto-pulls relevant medical records from the provider's EHR and ingests to NewgenONE using secure methods



**Outcome**: Decision-making is done within seconds (not months) with detailed audit trail. Reviewers focus on quick conclusion, not paperwork

#### **Use Case 2: Post Service ER Visit Appeal for Payers**
