The Customer

While the insurer wanted a modern, agile environment, it did not want to replace its Policy Administration System (PAS). To strike the right balance, it adopted a “hollowing out the core” strategy. Instead of touching the core system, it focused on upgrading the layers around it.

The Need for Modernization

Although the PAS remained stable, the insurer faced several challenges in the surrounding ecosystem:

- Workflows were complex and involved multiple manual steps
- Underwriting rules were hardcoded in the PAS, making updates slow and IT-dependent
- Documents were scattered across repositories, increasing compliance risks
- Teams lacked end-to-end visibility into new business and underwriting performance

The Transformation with Newgen

The insurer adopted NewgenONE, a low-code, AI-first platform that unifies workflow automation, content governance, and rule-based decisioning on a single framework. This move enabled the insurer to build a digital orchestration layer on top of its existing PAS that externalized and modernized key functions, including workflow routing, underwriting rule execution, discrepancy handling, and document management.

The PAS continued to store and manage policy data, while the new layer introduced agility, automation, and real-time visibility to the policy issuance process. Advanced integrations tied everything together, giving the insurer a connected and configurable digital ecosystem.
