Sonali Nigam is Non Resident and does not have PAN in India. Sosaley Australasia Pty Limited has been incorporated recently in Australia as a wholly owned foreign subsidiary of Jnanaadri Technovations Private Ltd. Therefore, there is no PAN no. available for this new promoter group. Further, KRIOS TECHNOLOGIES PRIVATE LIMITED (earlier mentioned in promoter group) has been strike off.Hence this company does not exist as on date. The Company follows the Trust Route for transferring shares to employees, wherein the Trust subscribes to shares issued by the Company. Since the Trust's shareholding is classified under the 'Non-Promoter, Non-Public' category, the aggregate outstanding ESOPs are also reported under the same category.
